**GRANT DISCRETIONARY APPROVAL – HORSES ON PARCEL AC:**

That we grant discretionary approval to Mr. Mel Annand to permit him to maintain horses on Parcel AC, Plan 101891000, in accordance with Section 10.1.2(3) of Zoning Bylaw 96-09, which allows for agricultural grazing of livestock as a discretionary use in an Urban Holding District.

This approval is subject to the following conditions:

1. That an appropriate shelter with a satisfactory foundation, as approved by the City Building Official, be erected in accordance with all municipal, provincial and national regulations.
2. That feed grain, hay, straw and other feed or bedding material is to be stored under cover.
3. That manure is to be removed regularly and so deposited as not to be a nuisance.
4. That corral fencing is aesthetically pleasing.

And further, that this discretionary approval will remain in effect only until such time as any further residential development occurs on the aforementioned parcel. **Motion Defeated**
